- (a) As of the close of business on January 25, 2021, TCS Advisors may be deemed to directly beneficially own 675,480 shares of Common Stock. As the investment advisor of TCS Advisors, TCS Management may be deemed to beneficially own the 675,480 shares of Common Stock beneficially owned by TCS Advisors. As the managing member of TCS Management, Eric Semler may be deemed to beneficially own the 675,480 shares of Common Stock beneficially owned by TCS Advisors. In addition, as of the close of business on January 25, 2021, Mr. Semler directly beneficially owns 200,000 shares of Common Stock.
- (b) TCS Management and TCS Advisors may be deemed to beneficially own 15.2% of the outstanding shares of Common Stock. Mr. Semler may be deemed to beneficially own 19.7% of the outstanding shares of Common Stock. These percentages were determined by dividing the shares of Common Stock held by each of the Reporting Persons by 4,441,635, which is the number of shares of Common Stock outstanding as of November 6, 2020, according to the Issuer's Form 10-Q filed on November 12, 2020 with the Securities and Exchange Commission.

(c) TCS Advisors, TCS Management and Eric Semler have the shared power to vote and dispose of the 675,480 shares of Common Stock directly owned by TCS Advisors. Eric Semler has the sole power to vote and dispose of the 200,000 shares of Common Stock directly owned by him.
